DIOCESAN APPOINTED FOUNDATION GOVERNOR VOLUNTARY AIDED SCHOOL

Thank you for agreeing to be nominated as a Foundation Governor of a Church of England Voluntary Aided School. Please read the following information carefully and if you feel that you are able and willing to undertake the special responsibilities of a Foundation Governor as outlined below, please sign at the bottom of this page. The Diocesan Board of Education will meet four times a year to consider nominations and will inform you of their decision promptly after their meeting. All new and reappointments of Foundation Governors must have a CRB check in line with CC policy.

As a Foundation Governor, you will share equally with the other members of the Governing Body many important responsibilities to the management and oversight of the school, including for example: management of the school budget; employment of the teaching staff and most of the support staff; responsibility for the exterior of the building including raising the 10% of costs that fall to the Governors.

But in addition to those common responsibilities, Foundation Governors are also charged with a special responsibility. They are appointed to ensure *'so far as is practicable, that the character of the school as a voluntary (Church of England) school is preserved and developed'*. (Section 78, 1996 Education Act). This means giving special attention to:

- Arrangements for collective worship (after consultation with the Headteacher) and ensuring that such arrangements are in accordance with the Trust Deed
- The religious education offered by the school ensuring that it follows the guidelines of the Diocese
- The arranging of an inspection of the denominational education (ie the worship, religious education and spiritual and moral development of pupils) as required under Section 48 of the Education Act, to take place alongside the full Section 5, Ofsted inspection
- Ensuring that the Diocesan Education Office is informed of the resignation of the Headteacher or Deputy Headteacher
- The appointment of staff ensuring that all teaching and support staff are made aware of the character and foundation of the school
- Bringing to the attention of the Diocesan Board of Education any matters requiring their attention regarding the school

Induction, support and guidance for Governors are available from the Diocese, in conjunction with the LA.
